OLD BUSINESS

Treasurers Report

Melody Scott reported that the following adjustments have been made to the 2010 budget: Prize money for Better Ball of Partners has been increased by \$145, \$50 has been added for our Halloween tournament, and Chip in and Birdie prize money has been increased by \$100. Income for 2010 is \$7.425, with a beginning balance of \$3,683. Budget for 2010 expenditures is \$8,020, meaning we will be using \$600 from our reserves in 2010. Budget approved. Copy attached.

Standing Rule Change

- (1) The group unanimously approved changing the standing rule to allow reduction of prize money if tournament participation is less than a full field. Winners would not receive less, just less places would be paid.
- (2) Bracketing change recommended by Joan Mumaugh which revises payout, especially for Handicap Tournament was approved.
- (3) It was approved to require 10 games within 12 months prior to the start of any tournament as qualification for participation.

Gold Cup

It was recommended and subsequently approved by the Board to alternate between Tuesday and Wednesday for the Gold Cup, depending on which group is sponsoring the tournament.

Invitational Update

Per Julie Osborn, the first meeting was held last week and chairpersons are all in place. We do need donations for raffle prizes and for wine for the Friday luncheon.
